\_\_\_\_\_ I understand by June 30<sup>th</sup> a complete copy of the report card for the entire school year and/or 4<sup>th</sup> quarter report card must be turned into VPW or the participant will not be able to receive equipment. The participant will also not be allowed to take part in practice until all documents are received. No exceptions will be allowed.

\_\_\_\_\_ I understand that by June 30<sup>th</sup> a completed Physical Examination Form must be turned into VPW or the participant will not be able to receive equipment. The participant will also not be allowed to take part in practice until all documents are received. No exceptions will be allowed. The ONLY form allowed is the current years Physical Form. \_\_\_\_\_ I understand that I will be asked to work volunteer time to support the operations of the program.

\_\_\_\_\_ I understand the refund policy for Vista Pop Warner is as follows for Football and Cheer. There are no full refunds after weigh ins, no refund for the late registrations fee and there is a \$20 nonrefundable processing fee. A football/cheer participant has until the first Saturday of practice in August to drop out of the program and receive a refund of half the registration fees. A request in writing to drop from the program must be submitted to the President and Vice President of VPW on time with all equipment returned. Equipment includes helmet, chin strap, pants, game pants, 7 piece pad set and shoulder pads. Failure to drop prior to the first Saturday in August or turn in the equipment will result in no refund and your fees will be considered a donation to VPW.

\_\_\_\_\_ I understand that there are no dogs allowed at the practice or game fields at any time. This rule is based on the rules of Vista Unified School District.

\_\_\_\_\_ I understand at the time of football equipment issue I will give a credit card deposit to Vista Pop Warner. At the time of exiting the VPW program or after dropping, I understand that I must return the helmet, chin strap, practice/game pants, 7 piece pad set and shoulder pads issues to the participant before my equipment deposit is returned. If I fail to return the equipment, I also understand that my card will be charged a \$250.00 fee in order to cover the cost of the equipment.

\_\_\_\_\_ I understand that my child is not guaranteed a team, coach or division. My child's will be placed according to what is in the best interest and safest for the child and association. In addition, participants are not guaranteed they will "track" with their previous coach.

\_\_\_\_\_ I support the method and result of the team placement process within the association and/or conference and understand that the decision of my child's placements on a team in final. I understand that VPW will attempt to place the participants in the lowest possible division.

\_\_\_\_\_ I understand that if I owe a balance of monies to VPW from the current or past seasons my child will not be allowed to start the current season until all balances are paid in full. This includes, but is not limited to scholarships, prior fundraisers, outstanding equipment and payment plans.

\_\_\_\_\_ I understand that I cannot use the Vista Pop Warner Tax ID number without the VPW Board of Directors knowledge and approval.

\_\_\_\_\_ I understand that any and all monies with regard to the team my child is on will be turned into the Treasurer and VPW only. This includes any donations, individual team fundraising, spirit packs etc.

\_\_\_\_\_ I understand that I will not enter into any contracts on behalf of Vista Pop Warner without the consent of the Board of Directors. Any contracts entered into without VPW Board approval will be my responsibility and not that of VPW.

\_\_\_\_\_ I understand that my child's age and weight determine what division they pay in. Vista Pop Warner supports no improper dieting and/or weight loss. My child might have to be moved due to their weight after practice has started, but prior to Mandatory Weight Certification, Tackle Players Only.

Each Pop Warner participant is required to submit these documents for certification. Certification is a process that is required and administered by National Pop Warner. No exceptions can or will be made.
